### Organisational background

Established in 2003, Malaria Consortium is one of the world's leading non-profit organisations specialising in the comprehensive prevention, control and treatment of malaria and other communicable diseases among vulnerable and under privileged populations. We increasingly find our work on malaria can be effectively integrated with other similar public health interventions for greater impact and therefore expanded our remit to include child health and neglected tropical disease interventions.

We work in Africa and Asia with communities, governments, academic institutions, and local and International organisations, to ensure effective delivery of services, which are supported by strong evidence.

Our areas of expertise include:

- disease prevention, diagnosis and treatment
- disease control and elimination
- systems strengthening
- research, monitoring and evaluation leading to best practice
- behaviour change communication
- national and international advocacy and policy development

### Country and project background

Malaria Consortium began working in Mozambique in 2005, supporting the development of distribution systems for long lasting insecticidal nets in the country.

Our work grew from there to focus on public health communications that sought to increase malaria awareness and preventive behaviours, particularly among school children and teachers. Using malaria as an entry point, we expanded into integrated community health projects that focused on diagnosing and treating the most common childhood illnesses – mainly malaria, pneumonia and diarrhoea. Throughout, we have consistently strived to integrate our work into government-led health programmes and ensure sustainability.

Malaria Consortium Mozambique has 4 operating offices, located in Maputo (Head Office), Inhambane, Nampula and Niassa, with allocated projects. These projects range from national level policy support to direct implementation of control programmes for malaria, tuberculosis, diarrhoea diseases and neglected tropical diseases.

### **Job purpose**

The M&E Specialist will put in place data quality assurance processes to ensure the timeliness of data entry and analysis as well as monitor the project indicators.

### **Scope of work**

The M&E Specialist will coordinate the implementation of the project plans and will develop a results framework for the project. The M&E Specialist will also provide technical support to and build capacity of project teams to ensure quality data is collected and entered and also contribute to Malaria Consortium's knowledge management activities through participation in M&E working groups.

### **Key working relationships**

The M&E Specialist will report to the Epidemiologist and will also collaborate with the Surveillance Technical Coordinator and Chief of party.

### **Key accountabilities (per cent of time spent on each area) – 100%**

- Lead on ensuring data quality and validation of the overall project's M&E environment and oversee all aspects of the performance measurement support for the project.
- Develop/update tools such as standard operating procedures, guidelines and other reference documents for M&E to ensure harmonized data collection systems, whenever needed.
- Work with country teams to review and monitor project-based M&E plans and indicators to track results.
- Conduct data verification and quality control exercises of project data, including data entered into iMISS in project implementation provinces, and lead on improvements of data quality.
- Ensure that all project staff has a clear understanding of the M&E plan including definitions.
- Provide training and coaching to project team/s on results framework and implementation of the M&E plan
- Write monthly reports on project indicators performance (desegregated by package and provinces) and update both DQA dashboard and project indicators dashboard and provide feedback to the teams.
- Contribute to strategic discussions on the project and its continuation opportunities.
- Ensure that the project data are reported in to PReS and relevant dashboards are created and for reporting and data-informed decision-making including training on PReS to project team/s.
